Benefit Highlights

(Core Plan is 100% Employer Paid)

Short Term Disability

Eligibility: All active full time employees working 30 hours or more per week.

Eligibility Waiting Period: You are eligible for coverage on the first of the month following 60 days.

New York DBL: Employees of a New York based facility will be covered under the DBL law of NY

by this insurer (Aetna)

Elimination Period: Injury: Benefits start on the 8th calendar day

Disease: Benefits start on the 8th calendar day

Scheduled Weekly Benefit: Core Plan: 50% of pre-disability earnings to \$200 weekly max

Minimum Weekly Benefit: \$25

Maximum Benefit Period: 26 weeks

Definition of Disability: Inability to perform own occupation and a Partial (80%) earnings test

Separate Periods of Disability: Less than 30 consecutive days.

Pre-Existing Exclusion: You will not be covered for any disability resulting from an injury or sickness that was

treated or should have been treated within 3 months of joining the plan until you have

been covered for 12 months.
